Report of the Lodge Officer Nominating Committee

The following names have been submitted to the Lodge Officer Nominating Committee for consideration of the membership. The election will take place at the summer Fellowship on May 22nd.

1. At least 45 days prior to the election the Nominating Committee shall nominate a slate of Lodge officers.
2. At least 30 days prior to the election the Nominating Committee shall advise each nominee of his nomination. At this time the nominee will indicate his willingness to run for the office to which he was nominated.
3. Anyone interested in running for a Lodge position may turn his name in to the Nominating Committee at least 45 days prior to the election but without requiring a second.
4. Nominations will be accepted from the floor on the day of the election but require a second.
5. Nominees or candidates for Lodge/Chapter offices must be present at the election to be elected unless otherwise approved by the Lodge Advisors prior to the election.
6. The presiding officer, prior to the vote, shall ask each nominee:

"IF ELECTED, WOULD YOU ACTIVELY SERVE FOR THE

COMING YEAR IN THE CAPACITY FOR WHICH YOU HAVE BEEN NOMINATED?"

Should the nominee be absent he should respond in writing prior to the election.

The Order Of The Arrow In The Summer Camp -

(The Quiver, Volume IV, Number IV, March 1956.)

Deep in the heart of every Arrow Brother there is an emotional attachment to the Council Summer Camp. No doubt, it was there he was inducted into the Order, and perhaps later he gave many hours of service to make the camp more attractive and more useful.

The ceremonial grounds, the campfire circle, the wooded trailways, the water front, the Troop site, the dining hall, and all that makes a camp are surrounded by an aura of reverence, and he feels a certain sense of ownership.

All of this is good as long as we keep a proper perspective and recognize that there are no special privileges due Arrow members except one -- that is the privilege to serve.

The Local Lodge in a summer camp is not an authoritative group. Their relationship to the administration of the camp is as individuals assigned to a camp job, working loyally under the Camp Director if they are members of the central staff, or with the Unit Leader if they are members of a Unit.

The Camp Director is Chief of the Fire and as such has the responsibility of all operations of the camp. The Lodge should not allow itself to be placed in a position where it gives its members authority over any phase of operation or makes them a special group with disciplinary powers.

There are numberless opportunities for Arrow members to cooperate with the camp administration and a few occasions when as a Lodge they may participate in an activity or service project.

They might put on a special number, such as Indian pageantry at a Campfire. A calling-out ceremony and recognition of new members can be staged at appropriate times before the whole camp.

They can help in orienting new campers, act as guides for visitors, handle parking of cars on visitor's day, and take over other worthy projects.

It may be impossible to schedule all activities in such a manner that there will be no conflict between some Arrow projects and the regular camp job of a given Arrow member. In this case there is NO choice - the Arrow member STAYS ON HIS JOB and in this way upholds the highest of Arrow Traditions.

We must never forget that in year-round Unit activities and in camp a fellow's first loyalty is to his Troop or Crew. Since an Arrow member is selected by his own associates he must never let them down. He has no choice but to uphold the highest standards in personal behavior. The Scout Law must be his constant guide with cheerful service as an ever-present objective.

BROTHERHOOD MEMBERSHIP* From the beginning of the Order in 1915, all members have been equal. There are no ranks. An Ordeal member is entitled to all the rights and privileges of membership in the Order. Yet, so important is the induction sequence that the Order strengthened it by creating Brotherhood membership. It is an opportunity for members to evaluate their past service to Scouting and to the lodge since their Ordeal induction. Brotherhood membership is sought by Arrowmen seeking to reaffirm their belief in the high purposes of the Order. Before becoming a Brotherhood member, each Arrowman makes a special effort to serve his troop and to learn about the Order. Each Brotherhood member commits himself to even more service to Scouting through the Order.....Brotherhood membership marks the completion of your induction into the Order of the Arrow. **After at least 10 months of active service you are eligible to seal your membership in the Brotherhood ceremony.**

You must meet five challenges before you can enter the Circle of the Brotherhood. When you are satisfied that you are meeting the first four, then complete the fifth challenge.

1. **Memorize the signs of Arrow membership.** Memorize the

Obligation of the Order, which you received from Allowat Sakima (printed on the membership card). Also memorize the Song, the Admonition, the sign of Ordeal membership, and the Arrow handclasp. 2. **Advance in your understanding of the Ordeal.** Gain a thorough understanding of the Ordeal through which you have passed. 3. **Serve your unit.** Retain your registration in Scouting. During a period of at least 10 months, strive to fulfill your Obligation by continuing and expanding your service to your own troop. 4. **Plan for service in your lodge.** Retain your registration in your lodge and keep your dues paid. Be aware that acceptance or Brotherhood membership involves a pledge of service to the lodge. Develop a concrete idea of how you plan to fulfill this pledge. 5. **Review your progress.** When you earnestly feel that you have met the four challenges above, write a letter to your lodge secretary. In this letter: i, Explain what you think the Obligation means; ii, Describe how you have been fulfilling this Obligation in your troop and in your daily life, and how you have used your understanding of the Ordeal to aid in this service; & iii, Describe your specific plans for giving service in the lodge program.

ARTICLE II

Lodge Paraphernalia and Requirements

Section A. Upon successful completion of the Ordeal, the Lodge shall provide each new Ordeal member with the following:

1. Ordeal Sash (given during ceremony), 2. OA handbook , 3. Lodge pocket flap, 4. Universal arrow ribbon , 5. OA membership card showing dues paid through the remainder of the Lodge year.

Section B. Upon successful completion of the Brotherhood, the Lodge shall provide each new Brotherhood member with the following: 1. Brotherhood sash (given during ceremony), 2. Lodge pocket flap, 3. OA membership card showing the member is now Brotherhood (dues date will remain the same)

Section C. Upon successful completion of the Vigil, the Lodge shall provide each new Vigil member with the following: 1. Vigil sash (given during ceremony), 2. Lodge pocket flap, 3. OA membership card showing the member is now Vigil (dues date will remain the same)

Section D. Lodge Pocket Flap

1. The Lodge Pocket Flap will be a fully embroidered emblem approved by the Executive committee of the Lodge showing the name and totem of the Lodge. The flap is restricted. Each member may purchase an additional 2 flaps of each rank every year. The flaps will be sold by the Lodge Treasurer. 2. The special events patches(NOAC, national jamboree, conclave, Indian summer, or any other event, which a contingent is sent) are to consist of a delegate and a trader. The amount of patches is to be chosen by the Treasurer and LEC, except for an additional 100 delegates and a trader that equals the amount of lodge members, which will be restricted and sold after the event, to lodge members who could not attend. 3. A general issue flap will be made which is not restricted. 4. The only Lodge flap that will be available at the council office will be the general issue.

Section E. Lodge Service Patch

1. The Lodge Service Patch shall be available to those members who have cheerfully contributed fifteen (15) hours of service on a project pre-approved by the Lodge Chief and Advisors.
2. The Lodge Secretary will maintain a file of hours, patches earned, and patches purchased (by name).
3. Service Patches will be made available to Lodge members at a cost determined by the Executive Committee. Service Patches will not be available for purchase at the council office.

The lodge flaps will be General, Ordeal, Brotherhood, and Vigil. 4. The Ordeal, Brotherhood, and Vigil flaps will be restricted to lodge members only. 5. The General flap will be unrestricted. 6. The special event patches (NOAC, National Jamboree, Conclave, Indian Summer, or any other event, which a contingent is sent) are to consist of one single flap. The amount of patches is to be chosen by the Treasurer and LEC, with a minimum of patches to be equal to the current number of members in the lodge. 7. The flaps will be sold by the lodge treasurer. The only flap to be available at the council office will be the general issue.
